



Article 01 General Municipal Operations

Recommended by the Selectmen and Budget Committee
To see if the Town will vote to raise and appropriate the sum of Four Million, Four Hundred Six Thousand, and Six Hundred Eleven Dollars (\$4,406,611) for general municipal operations. This article does not include appropriations in special or individual articles addressed separately.
(Majority vote required)

Article 02 CRF Solar Array

Recommended by the Selectmen and Budget Committee
To see if the Town will vote to raise and appropriate the sum of Seventeen Thousand Dollars (\$17,000) to be added to the existing Solar Array Capital Reserve Fund. (Majority vote required)

Article 03 CRF IT Hardware

Recommended by the Selectmen and Budget Committee
To see if the Town will vote to raise and appropriate the sum of Twenty-Five Thousand Dollars (\$25,000) to be added to the existing Information Systems Hardware Capital Reserve Fund.
(Majority vote required)

Article 04 CRF Revaluation

Recommended by the Selectmen and Budget Committee
To see if the Town will vote to raise and appropriate the sum of Twenty-Five Thousand Dollars (\$25,000) to be added to the existing Revaluation Capital Reserve Fund to meet our constitutional and statutory requirement that assessments are at full and true value at least as often as every fifth year. (Majority vote required)

Article 05 CRF Maintenance of Town Buildings

Recommended by the Selectmen and Budget Committee
To see if the Town will vote to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000) to be added to the existing Maintenance of Town Buildings Capital Reserve Fund. (Majority vote required)

Article 06 Road Repair

Recommended by the Selectmen and Budget Committee
To see if the Town will vote to raise and appropriate the sum of Three Hundred Fifty Thousand Dollars (\$350,000) for the purpose of public road repair and maintenance. (Majority vote required)

Article 07 CRF Highway Vehicles/Equipment

Recommended by the Selectmen and Budget Committee
To see if the Town will vote to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000) to be added to the existing Highway Vehicles/Equipment Capital Reserve Fund. (Majority vote required)



Article 08 CRF Repair of Town Bridges

Recommended by the Selectmen and Not Recommended by the Budget Committee
To see if the Town will vote to raise and appropriate the sum of Twenty-Five Thousand Dollars (\$25,000) to be added to the existing Repair Town Bridges Capital Reserve Fund. (Majority vote required)

Article 09 ETF Winter Maintenance

Recommended by the Selectmen and Not Recommended by the Budget Committee
To see if the town will vote to establish an expendable trust fund under RSA31:19-a for the purpose of winter maintenance and to raise and appropriate the sum of Fifty Thousand Dollars (\$50,000) to be placed in this fund. This amount to come from unassigned fund balance. Further, to name the selectmen as agents to expend from said fund. (Majority Vote Required).

Article 10 CRF POLICE FACILITY

Recommended by the Selectmen and Not Recommended by the Budget Committee
To see if the town will vote to raise and appropriate the sum of Twenty-Five Thousand Dollars (\$25,000) to be added to the existing Police Facility Capital Reserve Fund. (Majority Vote Required)

Article 11 Recycling

Currently the Town pays more per ton to recycle than the price per ton to dispose of trash refuse. The Town currently pays \$69.95 per ton to dispose of trash refuse and an average of \$125 per ton for recycling (79% more than trash disposal costs). The Town expends approximately \$480,000 per year on trash collection, disposal and recycling costs. At the current rates and if costs to recycle increase over time, do you want the Town to continue to sponsor a recycling program?
